Job Description

The Substitute Teacher supports the continuity of learning by delivering lessons and supervising students in the absence of regular secondary teachers. The role requires flexibility, strong classroom-management skills, and familiarity with the International Baccalaureate philosophy (MYP and/or DP).

Key Responsibilities

Teaching & Learning

- Deliver pre-prepared lesson plans in accordance with the IB curriculum (MYP/DP).
- Facilitate student learning using IB-aligned practices such as inquiry-based instruction and conceptdriven approaches.
- Provide clear instructions, manage learning activities, and maintain a positive learning environment.

Classroom Management

- Maintain a safe, respectful, and inclusive classroom atmosphere.



- Uphold school policies on behaviour, academic integrity, and student wellbeing.
- Monitor student engagement and ensure productive use of class time.

Collaboration & Communication

- Communicate effectively with the Secondary School Principal, IB Coordinators, and classroom teachers.
- Provide brief feedback on lessons taught, student progress, or issues encountered.

- Demonstrate professionalism, cultural sensitivity, and respect for the diverse international school community.

- Experience teaching or working in a secondary school setting.
- Strong English communication skills (additional languages an advantage).
- Ability to manage diverse classrooms with international learners.

- Experience with the IB Middle Years Programme (MYP) and/or Diploma Programme (DP).
- Teaching certification or equivalent qualification.
- Experience teaching in an international or multicultural environment.

Working Hours

- Approximately 5 hours per week, based on school needs.
- Schedule may vary depending on teacher absences and classroom coverage requirements.
